OFFICE ORDER

Subject: Establishment of Anti Ragging Committee for the Academic Year 2024-25.

Ragging in any form is a criminal offence and strictly prohibited inside and outside the Institute. Students found guilty of indulging in ragging will be subject to severe disciplinary action, including expulsion, as per the Anti-Ragging Regulations. Whosoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall on conviction, be punished as per the rules. If a student is involved in any act of ragging prior to taking admission, then such student will be denied admission in the Institute.

In compliance with the guidelines of the Hon. Supreme Court, University Grants Commission (UGC), AICTE & Govt. of Uttarakhand and to maintain a safe and respectful environment on campus, **Guru Nanak College, Jhajra, Dehradun**, has established an Anti-Ragging Committee. The primary objective of this committee is to prevent ragging, create awareness about its harmful effects, and take strict action against any incidents of ragging.

RESPONSIBILITIES:

- To conduct an on-the-spot enquiry into any incident of ragging referred to it by the faculty or student or parent or guardian, as the case may be: and the enquiry report along with recommendations shall be submitted to the Head of the Institution for action.
- To ensure the display of posters on Institution and Department Notice Boards and other prominent designated places.
- To formulate a procedure to collect an affidavit from all the first-year students at the time of admission.

In case of an emergency, please approach the nearest authority immediately. We encourage all students to cooperate and ensure that our campus remains free of ragging and is a safe space for learning and growth.
