The committee may provide counseling services to victims of harassment, helping them cope with any psychological impact and guiding them through the grievance redressal process.

4. Action and Recommendations:

After the investigation, if the complaint is found to be true, the committee can recommend disciplinary action against the perpetrator, which may include warnings, suspension, or even expulsion, depending on the severity of the incident.

5. **Documentation and Reporting:**

The committee keeps detailed records of complaints, actions taken, and resolutions. It is also required to submit an annual report to the governing body of the college and in some cases, to the government or other regulatory authorities, detailing the complaints received and actions taken.
